- You are not subject to any limit of stay in Hong Kong. Ordinary Residence You have ordinary residence in Hong Kong if you remain in Hong Kong legally, voluntarily and for a settled purpose (such as for education, employment or residence), whether of short or long duration. That status does not change if you are temporarily absent from Hong Kong.

### Hong Kong Immigration Information

To better plan for your visit to Hong Kong, you are advised to apply for PAR early (4 to 6 weeks in advance). If your PAR application is not successful, or if you intend to visit Hong Kong for more than 14 days, you may apply for a visa with the Hong Kong Immigration Department direct.

Visa information. Australian nationals whose passports have at least six months validity can enter Hong Kong for a period of up to three months without a visa. Those who wish to stay longer must apply for a visa from a Chinese Consulate at least six to eight weeks prior to departure.

S. citizens with Hong Kong residency, diplomats, and U.S. citizens that have not traveled outside of mainland China, Taiwan, and Macau in the past 14 days are permitted to enter Hong Kong. All non-Hong Kong residents arriving by air from any location other than mainland China, Macau, and Taiwan will be denied entry.

No visa or entry permit is required for any purpose if you hold any of the following travel documents: Hong Kong Special Administrative Region Passport, British National (Overseas) Passport, Hong Kong Certificate of Identity, Hong Kong Re-entry permit (for entry from the Mainland of China and the Macao Special Administrative Region only),

Applying for a Visa Canadian citizens may enter Hong Kong for a period of up to three months without a visa, provided they have a passport that is valid for at least one month beyond their return date. Upon arrival in Hong Kong, visitors must show proof of a return or onward ticket (unless they are in transit to mainland China or Macau).

Nationals from the following Southeast Asian countries enjoy visa free to Hong Kong not exceeding the period for visit stated below. Those who wish to stay longer must apply for a visa from a Chinese Consulate at least two week prior to departure.

Republic of Ireland Passport Holders Irish citizens whose passports have at least six months' validity can enter Hong Kong for a period of up to 90 days without a visa. Those who wish to stay longer must apply for a visa from Embassy of P.R.China in Ireland.

Visitors from over 145 countries are permitted visa-free entry for periods ranging from 7 to 180 days, to the Hong Kong Special Administrative Region for tourism or certain business-related activities. All visitors must hold a passport valid for more than 1 month.

Visa Information Visa exemptions are provided to citizens from over 160 countries and territories. You can stay for periods varying from seven to 180 days, depending on nationality. In general, all visitors to Hong Kong must have a passport that is valid for at least one month after the period of their intended stay in Hong Kong.
